DECISION

The instant Opposition case is filed by Societe Des Produits, Nestle, S.A. (Opposer), a foreign corporation organized under the laws of the Cayman Islands Switzerland against Application Serial No. 99299 for the registration of the trademark "FRESH 'N' FRUITY" on goods under Class 29 specifically for milk and dairy products and yoghurt, in the name of the New Zealand Cooperative Dairy Company Limited of Anchor House, 80 London Street, Hamilton, New Zealand. The New Zealand Cooperative Dairy Company Limited (Respondent-applicant) assigned its rights to the application for registration of the trademark "FRESH 'N' FRUITY" to NZDF Brands Limited of Una Place, Takanini, Auckland, New Zealand in a document entitled "Combined Assignment and Appointment of Domestic Representative, Assignment of Application for Registration of Trademark" dated 19 October 1999.

Opposer filed a verified Notice of Opposition on 17 August 1999 to Application Serial No. 99899 and published in the Intellectual Property Office (IPO) Official Gazette, Volume II, No. 1 page 93, January-February 1999 issue based on the followings grounds:

"1. That the registration of the mark "FRESH 'N' FRUITY" is proscribed under Section 4 par. (e) of R.A. 166 and Section 123, sub sec. 123.1 pars (g), (h) and (j) of R.A. 8293 for the reason that the mark is merely generic, descriptive or misdescriptive of the nature, kind, quality and/or other characteristics of the goods upon which it is used;

2. That the Oppositor, by itself or its subsidiaries, licensees, manufactures and distributes worldwide, including the Philippines, various food products and used and intends to use the generic words "fresh" and "fruity", either separately or in combination, to describe or designate its food products. To grant to the respondent-applicant the exclusive use as a registered mark would preclude the Oppositor and others similarly situated, of the same commonly used generic and descriptive phrase, to their great damage and prejudice.

In its Answer filed on 27 March 2003, respondent-applicant argued that"

"1. The trademark "FRESH 'N' FRUITY has been used in the Philippines since the year 1998;

2. NZDF Brands Limited and its predecessor "The New Zealand Cooperative Dairy Company Limited referred to jointly and/or alternatively as NZDF is the prior user and adopter and beneficial owner of the mark, having utilized, adopted and used it in local and international commerce since 1998;

3. NZDF filed an application for registration of the mark "FRESH 'n' FRUITY" on 28 April 1995;

4. NZDF as the legal and beneficial owner of the mark has the prior and exclusive right to said in accordance with Section 2-A of Republic Act No. 166."

The issues having been joined, the case set for pre-trial conference. There being no amicable settlement reached between the parties, the case proceeded to trial.

"88" Sales Invoice No.099 dated April 15, 2001 for the Trapik.com package, particularly fro radio advertisements to promote Respondent-Applicant's Country Goodness and FRESH 'N' FRUITY products in the Philippines. "89" Debit Memo No. 0257 dated November 23, 2001 issued by for FRESH 'N' FRUITY products sold back to New Zealand Dairy Foods, Makati City. "90" Debit Memo No.0066 dated April 18, 1998 for expenses made in the month of February 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "91" Debit Memo No.0065 dated April 18, 1998 for expenses made in the month of March 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "92" Debit Memo No.0073 dated May 31, 1998 for expenses made in the month of April 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "93" Debit Memo No.0074 dated May 31, 1998 for expenses made in the month of May 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "94" Debit Memo No.0083 dated June 1998 for expenses made in the month of June 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "95" Debit Memo No.0084 dated July 31, 1998 for expenses made in the month of July 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "96" Debit Memo No.0085 dated August 31, 1998 for expenses made in the month of August 1998 in the promotion and advertising of the Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines. "97" Debit Memo No.0086 dated September 30, 1998 for expenses made in the month of September 1998 in the promotion and advertising of the

Respondent-Applicant's Country Goodness and FRESH 'N' FRUTIY products in the Philippines.

The lone issue to be considered by this Office is whether the mark "FRESH 'N' FRUITY" is merely generic; descriptive is misdescriptive of the nature, kind, quality and /or characteristic of the goods upon which it is used and therefore incapable of appropriation and registration.

The challenged application having been filed under the provisions of the old Trademark Law or Republic Act 166, the instant case shall be decided based on the provisions thereof so as not to prejudice vested rights of the parties. The applicable provision of Republic Act 166 provides:

Sec.4 Registration of trademarks, tradenames and service marks in the principal register. $-x \times x$ The owner of a trademark, tradename or service mark, used to distinguish his goods, business or services from the goods, business or services of others shall have the right to register the same on the principal register, unless it: $x \times x$

(e) Consists of a mark or trade name which, when applied to or used in connection with the goods, business, or services of the applicant is merely descriptive or deceptively misdescriptive of them, or when applied to or used in connection with the goods, business or services of the applicant is primarily geographically descriptive or misdescriptive of them, or is primarily merely surname.

A mark is considered merely descriptive if it describes an ingredient, quality, characteristic, function, feature, purpose or use of specified goods or services.

A mark is suggestive if, when the goods or services are encountered under the mark, a multi-stage reasoning process, or the utilization of imagination, thought or perception is required in order to determine what attributes of the goods or services the mark indicates. (USPTO, Trademark Trial and Appeal Board, In re: Matsuhista Electric Corporation of America, Serial No. 76/021, 398, page 3)

In contrast to a descriptive trademark which only serves to tell what the product is, a suggestive tradename gives a hint as to the quality or nature of the product.

The word "fresh" is defined in Webster's Third New International Dictionary, Merriam-Webster Inc. Publishers, Copyright 1986 as "not salted, unsalted, not containing or composed of salt water; newly produced, gathered or made, not altered by processing, having its original qualities unimpaired, not exhausted or fatigued, full of or renewed with vigor, not stale, sour, decayed or deteriorated; experienced newly or anew, not known or experienced before; disposed to take liberties; to make fresh or spruce; just recently or just now; the early or beginning part of a duration.

The word "fruity" is defined in Webster's Third New International Directionary, Merriam-Webster Inc. Publishers, Copyright 1986 as 1) relating to a fruit, resembling or suggesting a fruit (as to taste or color) b) retaining the flavor and fragrance of grape 2) having a rich, strong or spicy quality b) sweet or sentimental especially to excess.

The words "FRESH" and "FRUITY" apparently do not pertain or have significance to yoghurt, milk or dairy products. Moreover, the "fresh" alone does not automatically call to mind these products. The word "FRESH" used as an adjective can describe a variety of things and can be used in different contexts. While it may describe milk, dairy products and yoghurt, it can also describe other products. The English word "FRUITY" can describe a gamut of other products as well, not merely yoghurt. Thus, "FRESH 'N' FRUITY" is more of a suggestive term than a descriptive mark.

It is also worthy of note that the applicant was required by the trademark examiner to disclaim the words "fresh" and "fruity" when used separately, but allowed the use of the words 'fresh' and 'fruity' combined through a letter 'N'.

In this regard, citing foreign authorities on the matter, the Supreme Court in the case of Ong Ai Gi vs. Director of the Philippine Patent Office, G.R. No. L-6235, March 28, 1955 explains:

"xxx A descriptive word may be admittedly distinctive, especially if the user is the first letter of the article. It will however, be denied protection, not because I lacks Distinctiveness but rather because others are equally entitled to its use". (2 Callman, Unfair Competition and Trademarks, pp. 869-870)

The claim that a combination of a word may be registered as a trade name is no justification for applying the rules or principles hereinabove mentioned. The use of a generic name in a trade name is always conditional i.e. subject to the limitation that the registrant does not acquire the exclusive right to the descriptive or the generic term or word. "... A combination of marks or words may constitute a valid trademark or (incase of words) a trade name even though some of the constituent portions thereof would not be subject separately, to exclusive appropriation as such. Thus, although a word may be descriptive and not subject to exclusive use as a trademark, it may properly become the subject of a trademark by combination with another word or term which is non descriptive, although no exclusive right to the word or term is created. (52 Am Jur553.)"

Incidentally, although not put in issue in the proceedings and even though the respondent-applicant based its application for registration of the mark on its home registration (Exhibit1), it had submitted voluminous evidence consisting of the affidavit and testimony of witness Mercelita Alcantara, Operations Manager of the licensed distributor of "Fresh 'N' Fruity" products (Exhibit "4"), photographs of products bearing the mark "Fresh 'N' Fruity" (Exhibit "5"); commercial invoices, shipping documents, (Exhibit "9", "10", "11", "12" to "22"); promotional items (Exhibits "23" to "28"); Certificates of Product Registrations (Exhibits "30" to "39")' delivery receipts and sales invoices dated from 1998 up to (Exhibit "40" to "45"); assorted memos for the expenses incurred in advertising, promotional calendars, delivery receipts (Exhibit "46" to "98") to establish prior use in the Philippines of the mark "FRESH 'N' FRUITY". Its use entitles respondent to acquire trademark ownership over the mark "FRESH 'N' FRUITY" in connection with yoghurt, milk and dairy products. Section 2-A of the old Trademark Law, R.A. 166 provides:

"Sec. 2 – A. Ownership of Trademarks and service marks, how acquired. – Anyone who lawfully produces or deals in merchandise of any kind or who engages in any lawful; business, or who renders any lawful service in commerce, by actual use thereof in manufacture or trade, in business, and in the service rendered, may appropriate to his exclusive use a trademark, trade name or service fro the merchandise, business or service of others. The ownership of a trademark, trade name or servicemark, heretofore or hereafter appropriated as I this section provided, shall be recognized and protected in the same manner and to the same extent as are other property rights known to the laws.

WHEREFORE, premises considered the instant Opposition is hereby DENIED. Consequently, Application Serial No. 99899 for the registration of the trademark "FRESH 'N' FRUITY" for "milk, dairy products, yoghurt" in the name of NZDF BRANDS LIMITED (owner by way of assignment from THE NEW ZEALND COOPERATIVE DAIRY CO.), is hereby GIVEN COURSE.

Let the filewrapper of the trademark "FRESH 'N' FRUITY" subject matter of this case together with a copy of this Decision forwarded to the Bureau of Trademarks for appropriate action.
