ORDER

AUGUST STORCK KG ("Opposer"), filed on 03 October 2011 an opposition to Trademark Application Serial No. 4-2011-01788. This Bureau issued a Notice to Answer and served upon a copy thereof to HUANG JUAN JUAN ("Respondent-Applicant") on 09 November 2011. The Respondent-Applicant filed his Answer on 06 December 2011.

On 28 March 2012, the Respondent-Applicant filed a letter addressed to the Director of the Bureau of Trademarks and stated that he is no longer interested in registering its trademark application for the mark "MERCI & DEVICE".
