ORDER

AUSTRALIAN WOOL INNOVATION LTD. ("Opposer"), filed on 15 June 2012 an opposition to Trademark Application Serial No. 4-2011-012919. The application, filed by RAMON ONG ("Respondent-Applicant"), covers the mark "WOOLRICH" for use on goods under Class 25.

This Bureau issued a Notice to Answer dated 07 January 2013 and served upon a copy thereof to Respondent-Applicant on 14 January 2013. The Respondent-Applicant filed his Answer on 14 January 2013.

On 06 November 2013, the Opposer filed a Manifestation stating that it is no longer interested in pursuing the opposition against Respondent-Applicant's Trademark Application No. 4-2011-012919 for the mark WOOLRICH.
