ORDER

BLOOMBERG FINANCE L. P. ("Petitioner"), filed on 24 September 2013 a petition for cancellation of Trademark Registration No. 4-2012-003068 on the ground that the registration of the mark ONE BLOOMBERG PLACE WITH DEVICE will violate Section 123.1 (c) (d), (e) and (f) of Republic Act 8293 also known as The Intellectual Property Code of the Philippines ("IP Code").

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to **FEDERAL LAND, INC** (Respondent-Registrant) on 05 November 2013. The Respondent-Applicant filed its Answer on 16 December 2013.

On 29 May 2014, the parties filed a Joint Motion stating, among other things, that the Petitioner is withdrawing its petition for cancellation and Respondent-Registrant is withdrawing its registration of the trademark ONE BLOOMBERG PLACE WITH DEVICE under Registration No. 4-2012-003068.

With the withdrawal of the petition for cancellation by the Petitioner and withdrawal of the trademark registration by the Respondent-Registrant, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant cancellation case is hereby DISMISSED. Let the filewrapper of Trademark Registration No. 4-2012-003068 be returned, together with a copy of this Decision, to the Bureau of Trademarks for information and appropriate action.
