ORDER

GINEBRA SAN MIGUEL INC. ("Opposer"), filed on 13 June 2013 an opposition to Trademark Application Serial No. 4-2012-008052 on the ground that the registration of the TANDUAY ORO mark will violate Sections 123.1 (d) and (e) of the IP Code.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to TANDUAY DISTILLERS, INC., ("Respondent-Applicant") on 02 July 2013. The Respondent-Applicant did not file its Answer.

On 22 January 2014, the Respondent-Applicant filed a Motion to Withdraw Application stating that it is withdrawing its application for the mark TANDUAY ORO.


Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**.
