DECISION

GLAXO GROUP Limited, ("Opposer")1 filed on 26 September 2011 an opposition to Trademark Application Serial No. 4-2010-005816. The application filed by 2 WORLD TRADERS SUBIC, INC., ("Respondent-Applicant")2 which covers the mark "ZINAF" used on pharmaceuticals as powder for injection under class 5 of the International Classification of Goods and Services.3

Opposer alleges among other things, the following:

- "1. Opposer is the owner of the mark "ZINNAT" registered under Philippine Trademark Registration No. 041714 on November 14, 1988 in class 5 for pharmaceutical preparation and substances.
- "2. The Respondent-Applicant's mark "ZINAF" for pharmaceuticals as powder for injection in class 5 nearly resembles Opposer's mark "ZINNAT", hence registration in proscribed under Sec. 123.1 (d) of R. A. 8293.

Sample promotional materials for the products bearing the trademark ZINNAT in the Philippines

This Bureau issued a Notice to Answer and served a copy thereof upon the Respondent-Applicant on 13 October 2011. The Respondent-Applicant, however, did not file an Answer. Hence, the instant case is deemed submitted for decision based on the opposition and evidence submitted by the opposer. There is no dispute that the competing marks are identical or at least confusingly similar. The goods or services indicated in the Respondent-Applicant's trademark application are also similar and/or closely related to the Opposer's.

The records however, show that in IPC No. 14-2011-003324, which involves the subject trademark application, this Bureau already rendered a decision⁵, the dispositive portion of which provides, to wit:

"WHEREFORE, premises considered, the instant Opposition is hereby SUSTAINED. Let the file wrapper of Trademark Application No. 4-2010-005816 be returned, together with a copy of this Decision, to the Bureau of Trademark for information and appropriate action."

The Respondent-Applicant did not seek reconsideration nor appeal the above-quoted decision, thus, on 26 December 2012, this Bureau issued an Entry of Judgment/Execution of Decision stating that Decision No. 2012-168 became final and executory on 23 October 2012 and is hereby recorded in this Bureau's Book of Entries of Judgments. Consequently, the filewrapper of the subject trademark application has already been returned to the Bureau of Trademarks for appropriate action pursuant to the said decision.

With the finality of the said decision rejecting the Respondent-Applicant's trademark application for the mark ZINAF, there is no more trademark application to oppose.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED for the reason stated above.
