ORDER

GOLDEN ABC, INC. ("Opposer"), filed on 10 April 2012 an opposition to Trademark Application Serial No. 4-2010-009467 on the ground that the subject mark "OXYGEN FRESH" is confusingly similar to the Opposer's registered "OXYGEN" marks.

This Bureau issued a Notice to Answer and served a copy thereof to the Respondent-Applicant JOHNSON & JOHNSON on 28 May 2012. Instead of filing an answer, the Respondent-Applicant filed on 15 March 2013 a Manifestation stating that it has withdrawn its application for registration of the trademark OXYGEN FRESH.

Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.
