ORDER

GRANDVISION, MULTIBRANDS SAS and SOLARIS ("Opposers"), filed on 24 September 2012 an opposition to Trademark Application Serial No. 4-2010-010415 on the ground that the subject mark "GRUPPO SOLARIS AND DEVICE" is confusingly similar to the Opposers' registered "SOLARIS" mark.

This Bureau issued a Notice to Answer and served a copy thereof to the Respondent-Applicant ROSHAN COMMERCIAL CORPORATION on 08 October 2012. Instead of filing an answer, the Respondent-Applicant filed on 30 April 2013 a Manifestation stating that it is withdrawing its application for registration of the trademark GRUPPO SOLARIS AND DEVICE.

Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.
