### **ORDER**

IRWIN INDUSTRIAL TOOL COMPANY ("Opposer"), filed on 22 October 2012 an opposition to Trademark Application Serial No. 4-2012-004554 on the ground that the subject mark "JORAN" is confusingly similar to the Opposers' registered "JORAN" mark.

This Bureau issued a Notice to Answer and served a copy thereof to the Respondent-Applicant CHARLES JONATHAN SY on 26 November 2012. On 06 June 2013, the Opposer filed a Manifestation stating that it received a copy of the Withdrawal of Trademark Application filed by the Respondent-Applicant with the IPOPHL involving the subject trademark application no. 4-2012-004554 with undertaking not to use the mark JORAN or marks confusingly similar thereto in the future. Attached to the manifestation is an original copy of the Respondent-Applicant's Withdrawal of Trademark Application dated 29 May 2013 addressed to the Director of the Bureau of Trademarks.

Accordingly, with the withdrawal by the Respondent-Applicant of his trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Application Serial No. 4-2012-004554 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
