ORDER

MARS, INCORPORATED, (Opposer) filed on 31 August 2012 an opposition to Trademark Application Serial No. 4-2012-01135. The application, filed by **CONSUMER CARE PRODUCTS, INC.**, (Respondent-Applicant), covers the mark "**CATCARE**" for cat food under class 31 of the International Classification of goods.

This Bureau issued a Notice to Answer and served a copy thereof upon the Respondent-Applicant on 26 September 2012. The Respondent-Applicant filed its Answer on 12 November 2012.

In compliance to Office Order No. 154, s. 2010 (*"Rules of Procedure for IPO Mediation Proceedings"*) and Office Order No. 197, s. 2010 (*"Mechanics for IPO Mediation and Settlement Period"*), this Bureau issued on 17 January 2013 Order No. 2013-017 referring the case to mediation.

On 11 April 2013 the ADR Services of this Bureau submitted a Mediator's Report together with the Joint Manifestation and Motion to Dismiss Opposition filed by the parties on 15 April 2013 stating that the present proceedings be dismissed. With the parties Manifestation, there is no more reason or basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**. Let the filewrapper of Trademark Application Serial No. 4-2012-001135 be returned, together with a copy of this Order and the aforementioned Joint Manifestation and Motion to Dismiss Opposition to the Bureau of Trademarks for information and appropriate action.
