MEDICHEM PHARMACEUTICALS, INC., (Opposer) filed on 23 February 2012 an opposition to Trademark Application Serial No. 4-2011-501522. The application, filed by **GLAXOSMITHKLINE TRADING SERVICES LIMITED** (Respondent-Applicant), covers the mark **"SOLDEO"** for use on pharmaceutical preparations and substances for the treatment and/or alleviation of diseases and disorders of the central nervous system, and psychiatric related diseases and disorders under class 5 of the International Classification of goods.

This Bureau issued a Notice to Answer and served a copy thereof upon the Respondent-Applicant on 14 March 2012. The Respondent-Applicant filed its Answer on 13 June 2012.

In compliance to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation and Settlement Period), this Bureau issued on 07 February 2012 Order No. 2012-47 referring the case to mediation.

On 21 September 2012 the ADR Services of this Bureau submitted a Mediator's Report stating the refusal of the Opposer to undergo mediation. On 28 February 2013, Opposer filed a Manifestation with Motion to Withdraw Opposition stating that it is withdrawing its opposition to the application for the registration of the mark "SOLDEO". With the Opposer's Manifestation, there is no more reason or basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED.** Let the filewrapper of Trademark Application Serial No. 4-2011-501522 be returned, together with a copy of this Order and the aforementioned Manifestation with Motion to Withdraw Opposition of the Opposer, to the Bureau of Trademarks for information and appropriate action.
