ORDER

OUTRIGGER HOTELS HAWAII (Opposer), filed on 23 February 2011 an opposition to Trademark Application Serial No. 4-2010-005211. The application, filed by TROPICAL ISLAND DREAMS AND ADVENTURE, INC. (Respondent-Applicant), covers the mark "ANILAO OUTRIGGER RESORT " for use on beach resort/dive resort under class 43 of the International Classification of goods.

This Bureau issued a Notice to Answer and served a copy thereof upon the Respondent-Applicant on 12 April 2011. The Respondent-Applicant filed its Answer on 27 May 2011.

On 04 May 2012, the Respondent-Applicant filed a letter addressed to the Director of the Bureau of Trademarks stating that it is formally withdrawing its trademark application. This Bureau was furnished a copy of the said letter and takes cognizance thereof via judicial notice.

With the withdrawal by the Respondent-Applicant's trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**. Let the filewrapper of trademark Application Serial No. 4-2010-005211 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
