ORDER

SANOFI PASTEUR, INC. ("Petitioner") filed on 04 June 2013 a petition to cancel Patent No. 1-2000-002082. The patent, issued to ASTRAZENECA AB ("Respondent-Patentee") on 16 April 2010, is titled "*Pharmaceutical Compositions*". The petition is anchored on Sections 21, 22 and 24 of Rep. Act No. 8293, also known as the Intellectual Property Code of the Philippines ("IP Code").

This Respondent-Patentee filed its Answer on 11 October 2013.

In compliance to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation Settlement Period"), this Bureau issued on 12 November 2013 Order No. 20103-243 referring the case to mediation.

On 21 May 2014, the Alternative Dispute Resolution Services of this Bureau submitted a Mediator's Report stating the successful mediation of the parties' dispute. Attached to the Mediator's Report is a copy of the parties "Settlement Agreement". Subsequently, the Petitioner filed a Motion to Withdraw the petition citing the settlement agreement it reached with the Respondent-Patentee.

WHEREFORE, premises considered, the Petitioner's motion is hereby GRANTED. Accordingly, the instant petition for cancellation is DISMISSED. Let the filewrapper of Patent No. 1-2000-002082 be returned, together with a copy of this Decision, to the Bureau of Patents for information and appropriate action,
