THE PROCTER & GAMBLE CO., ("Opposer") filed on 05 September 2012 an opposition to Trademark Application Serial No. 4-2012-002627. The application filed by **ACS MANUFACTURING CORP.,** ("Respondent-Registrant") covers the mark **"SHIELD & DEVICE**" for use on goods under Class 03.

This Bureau issued a Notice to Answer dated 19 September 2012 and served a copy thereof upon the Respondent-Opposer on 25 September 2012. The Respondent-Opposer filed its Answer on 27 November 2012.

In compliance to Office Order No. 154, s. 2010 (*'Rules of Procedure for IPO Mediation Proceedings'*) and Office Order No. 197, s. 2010 (*'Mechanics for IPO Mediation and Settlement Period'*), this Bureau issued on 17 January 2013 Order No. 2013-016 referring the case to mediation.

On 29 May 2013, this Bureau received a "MEDIATOR'S REPORT" indicating the successful mediation of the instant case. Attached to the report is the "UNDERTAKING" executed by counsel for Respondent-Applicant. The Undertaking states, among other things:

"4. Pending the Opposition, ACS filed another trademark application on August 3, 2012 for "SHIELD" with a circular shield device, which was designated Application No. 4-2012-009644, to wit:

"5. The IPOPHL granted the registration of Trademark Application No. 4-2012-009644 for "SHIELD" with the circular shield device on December 6, 2012.

"6. In light of said registration, ACS withdrew its earlier-filed trademark Application No. 4-2012-002627 for "SHIELD" (& DEVICE)," which was the trademark subject of P&G's Opposition."

With the express withdrawal by the Respondent-Applicant of its trademark application, there is no more reason or basis to proceed with this case.
