**ORDER**

UNILEVER N. V. ("Opposer") filed on 27 April 2012 an opposition to Trademark Application Serial No. 4-2011-010125. The application filed by MY SANCTUARY WELLNESS CENTER INC. ("Respondent-Applicant") covers the mark NANO CLEAR AND DEVICE for use on goods under Classes 03 and 05. The opposition is anchored on Sections 123.1 (d), (e), (f) and (g) of R.A. 8293 otherwise known as The Intellectual Property Code of the Philippines.

On 22 June 2012, the Respondent-Applicant filed its Answer refuting the material allegations of the Opposer.

In compliance to Office Order No. 154, s. 2012 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation and Settlement Period"), this Bureau issued on 11 July 2012 Order No. 2012-147 referring the case to mediation.

On 03 December 2012, the ADR Services of this Bureau submitted a Mediator's Report. Attached to the report is the Opposer's Manifestation and Motion filed on 23 November 2012 and a copy of Respondent-Applicant's letter addressed to the Bureau of Trademarks stating that it is no longer interested in registering its NANO CLEAR AND DEVICE covered by Trademark Application Serial No. 4-2011-010125. With the withdrawal of the Respondent-Applicant's trademark application, there is no more reason or basis to proceed with this case.

WHEREFORE, premises considered, this case is hereby **DISMISSED**. Let the filewrapper of Trademark Application Serial No. 4-2011-010125 be returned, together with a copy of this Order, to the Bureau of Trademarks for information and appropriate action.
