

ORDER

Watts Regulator Co. ("Petitioner"), filed on 18 July 2013 a petition for cancellation of Trademark Registration No. 4-2009-000033. The petition is anchored on Section 123.1 (e) of Rep. Act No. 8293, also known as the Intellectual Property Code of the Philippines.

On 30 October 2013, **Limson Marketing, Inc.** ("Respondent-Registrant"), filed its Answer to the petition refuting the Petitioner's allegations.

In compliance to Office Order No. 154, s. 2010 ("*Rules of Procedure for IPO Mediation Proceedings*") and Office Order No. 197, s. 2010 ("*Mechanics for IPO Mediation and Settlement Period*"), this Bureau issued on 13 January 2014 Order No. 2014-016 referring the case to mediation.

On 12 February 2014, the parties filed a Joint Motion to Dismiss praying that the petition for cancellation be dismissed on the ground that they have settled the case amicably to their full and mutual satisfaction.


Accordingly, with the parties' Joint Motion to Dismiss, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant petition case is hereby **DISMISSED**.

Let the filewrapper of Trademark Registration No. 4-2009-000033, together with a copy of this Order, be returned to the Bureau of Trademarks (BOT) for appropriate action.
