ORDER

ILLINOIS TOOL WORKS, INC. ("Opposer"), filed on 03 June 2013 an opposition to Trademark Application Serial No. 4-2012-001405 on the ground that the registration of the mark **WYNNS'S AND LION DEVICE** will violate Section 123.1 (a) (d) (e) and (f) of R.A. 8293 also known as the Intellectual Property Code of the Philippines ("IP Code").

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to Ms. Alice Chua (Respondent-Applicant) on 15 July 2013. The Respondent-Applicant filed his Answer on 14 October 2013.

On 21 November 2013, the case was referred to mediation. On 25 July 2014, the Mediation Report was forwarded to this office together with the attached Compromise Agreement and a Joint Manifestation from the parties indicating the withdrawal by the Opposer of its opposition to the registration of the mark WYNN'S & LION DEVICE.

Accordingly, with the withdrawal of the opposition by the Opposer, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Application Serial No. 4-2012-001405 be returned, together with a copy of this Order to the Bureau of Trademark (BOT) for information and appropriate action.
