## ORDER

NEW LOOK LIMITED ("Petitioner"), filed on 04 March 2011 a petition for cancellation of Trademark Registration No. 4-2006-000282. The registration issued on 9 April 2009 in favor of GRACE PALAGANAS ("Respondent-Registrant") covers the mark NEW LOOK & DEVICE for use on goods under Class 25.

This Bureau issued an Alias Notice to Answer dated 15 February 2013. The Respondent-Registrant, however, did not file an Answer.

On 16 September 2014, the Petitioner filed a Manifestation stating that the parties have reached an amicable settlement and the Respondent-Registrant has assigned her trademark registration in favor of the Petitioner. Attached to the Petitioner's Manifestation is a copy of a page from the IPO website showing that the subject trademark registration has been assigned to the Petitioner.

The records of the Intellectual Property Office of the Philippines, in particular the Trademarks Registry, confirm the Petitioner's manifestation. Accordingly, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Registration No. 4-2006-000282 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
