

### ORDER

CHRISTOPH PAUL JACOB LOCHER ("Opposer"), filed an opposition to Trademark Application Serial No. 4-2012-008926. The contested application filed by **CHARMAINE GASKELL PINEDA** ("Respondent-Applicant") covers the mark **PANIZZA JANDO** for use on for use on coffee, tea, cocoa, sugar, rice, tapioca, sago, artificial coffee; flour and preparations made from cereals, bread, pastry and confectionery, ices: honey, treacle; yeast; baking-powder; salt, mustard; vinegar, sauces (condiments); spices; ice under Class 30 of the International Classification of Goods. The opposition is anchored on Section 123.1 paragraphs (c), (h) and (i) of R.A No. 8293, also known as the Intellectual Property Code of the Philippines ("IP Code").

Pursuant to the Regulations on the Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to Respondent-Applicant on 25 January 2013. The Respondent-Applicant filed its Answer on 11 March 2013. On 29 April 2014, this Bureau issued Order No. 2013-675 requiring Respondent-Applicant to submit the original Special Power of Attorney within five (5) days from the receipt of the said Order. However, Respondent-Applicant failed to submit an original copy of its Special Power of Attorney. Thus, Order No. 2013-1195 was issued declaring the Respondent-Applicant in default for failure to comply with the Order.


On 27 October 2014, the Opposer filed a Consolidated Motions to Dismiss stating that it is no longer interested in questioning the right of Respondent-Applicant to register and use the assailed marks including the trademark "PANIZZA JANDO". The Opposer thus manifest its withdrawal of the notices of opposition and petition for cancellation it filed against the Respondent-Applicant.

Accordingly, with the withdrawal by the Opposer of its opposition to the subject trademark application, there is no more reason nor basis to proceed with this case.

**WHEREFORE**, premises considered, the instant opposition case is hereby **DISMISSED**. Let the filewrapper of Trademark Application Serial No. 4-2012-008926 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
