**ORDER**

**CHRISTOPH PAUL JACOB LOCHER** ("Petitioner") filed a petition to cancel Trademark Registration No. 4-2012-000544. The contested registration issued to **CHARMAINE GASKELL PINEDA** ("Respondent-Registrant"), covers the mark **PANIZZA** for use on coffee, tea, cocoa, sugar, rice, tapioca, sago, artificial coffee; flour and preparations made from cereals, bread, pastry and confectionery, ices; honey, treacle; yeast; baking-powder; salt, mustard; vinegar, sauces (condiments); spices; ice under Class 30 of the International Classification of Goods.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to Respondent-Registrant on 08 February 2013. The Respondent-Registrant filed its Answer on 11 March 2013. Thereafter, on 18 March 2013, this Bureau issued Order No. 2013-448 requiring the Respondent-Registrant to submit the original Verification and Certification of Non-Forum Shopping and Special Power of Attorney. The Respondent-Registrant, however, failed to comply. Thus, on 03 February 2014, the Respondent-Applicant was declared in default for failure to comply with the Order.


On 27 October 2014, the Petitioner filed a Consolidated Motions to Dismiss stating that it is no longer interested in questioning the right of Respondent-Registrant to register and use the assailed marks including the trademark "PANIZZA". The Petitioner thus manifests its withdrawal of the notices of opposition and petition for cancellation it filed against the Respondent-Registrant.

Accordingly, with the withdrawal by the Petitioner of its petition to cancel the subject trademark registration, there is no more reason nor basis to proceed with this case.

**WHEREFORE**, premises considered, the instant cancellation case is hereby **DISMISSED**. Let the filewrapper of Registration No. 4-2012-000544 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
