#### ORDER

NUTRI-ASIA, INC. ("Opposer"), filed on 09 February 2015 an opposition to Trademark Application Serial No. 4-2014-500605 on the ground that the subject mark "DALISAY" is confusingly similar to the Opposer's registered "DALISAY PATIS" mark.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to MABUHAY INTERFLOUR INCORPORATED ("Respondent-Applicant") on 11 February 2015. The Respondent-Applicant failed to file its Answer.

On 19 June 2015, the Respondent-Applicant filed a Motion to Withdraw Application stating that it is no longer interested in pursuing its trademark application.

Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.
