

DECISION

British American Tobacco (Brands) Ltd.1 ("Opposer") filed an opposition to Trademark Application Serial No. 4-2012-008579. The contested application, filed by Mighty Corporation² ("Respondent-Applicant"), covers the mark "LUCKY STAR" for use on "cigarettes" under Class 34 of the International Classification of Goods³.

The records show, however, that in IPC Case No. 14-2013-00134⁴, which involves the subject application, this Bureau already rendered a decision⁵, the dispositive portion of which provides:

"WHEREFORE, premises considered, the instant opposition is hereby SUSTAINED. Let the filewrapper of Trademark Application Serial No. 4-2012-008579 be returned, together with a copy of this Decision, to the Bureau of Trademarks for information and appropriate action."

The parties did not appeal the afore-quoted decision. Thus, on 10 August 2016, this Bureau issued an Entry of Judgment/Execution of Decision stating:

"The Decision became final and executory on June 10, 2016 and accordingly, is hereby recorded in this Bureau's Book of Entries of Judgment."

With the finality of the decision sustaining the opposition to the subject trademark application, there is no more actual controversy or legal basis to proceed with this case.
