ORDER

KIDZANIA, S.A. DE C.V., ("Opposer") filed on 05 August 2016 a Motion to Withdraw Opposition manifesting, that:

- "1.) On 01 August 2016, Opposer and Respondent-Applicant agreed to settle the dispute between them and entered into a Global Co-Existence Agreement with regard to the concurrent use of their respective marks in relation to goods and services in various international classes.
- 2.) Pursuant to the Global Co-Existence Agreement, each party agreed to refrain from contesting or challenging the use and registration by the other party of its marks. Moreover, the parties agreed to withdraw all the relevant opposition cases which were filed against each other's trademark applications within seven (7) days from the date of execution of the Agreement.
- 3.) Accordingly, and in compliance with the Global Co-Existence Agreement, Opposer is hereby withdrawing its opposition to Respondent-Applicant's application for registration of the mark **kidzooona** bearing Application No. 4-2013-012158.
- 4.) In view of the foregoing, Opposer respectfully requests that the present case be immediately dismissed and the records of the case be forwarded to the Bureau of Trademarks for appropriate action, including the allowance of the application for registration of the mark **kidzooona** bearing Application No. 4-2013-012158."

Accordingly, with the withdrawal by the Opposer of its opposition to the subject trademark application, there is no more reason or basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**. Let the filewrapper of Trademark Application Serial No. 4-2013-012158 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
