Please be informed that Order No. 2016 - 282 (D) dated December 12, 2016 (copy enclosed) was promulgated in the above entitled case.



ORDER

JOLLIBEE FOODS CORPORATION ("Opposer"), filed on 01 December 2015 an Opposition to Trademark Application Serial No. 4-2014-013574. The application, filed by MARIA JOY A. TING ("Respondent-Applicant"), covers the mark "JOYBEES ORGANIC HONEY" for use on goods under Class 30. The Opposition is anchored on Section 123.1 subparagraphs (d), (e) and (f) of R.A. No. 8293, also known as the Intellectual Property Code of the Philippines ("IP Code").

This Bureau issued a Notice to Answer and served a copy thereof upon the Respondent-Applicant on 29 January 2016. The Respondent-Applicant however, was declared in default for failure to file an Answer.

On 11 October 2016, the Respondent-Applicant filed a Manifestation and Petition to Withdraw Application stating that she is withdrawing her application for the mark "JOYBEES".

Considering the withdrawal by the Respondent-Applicant of her trademark application, there is no more reason or basis to proceed with the instant case.

WHEREFORE, premises considered, the Trademark Application with Serial No. 4-2014-013574 is hereby WITHDRAWN. Accordingly, the instant Opposition case is DISMISSED. Let the filewrapper of Trademark Application Serial No. 4-2014-013574 be returned, together with a copy of this Order to the Bureau of Trademark (BOT) for information and appropriate action.
