

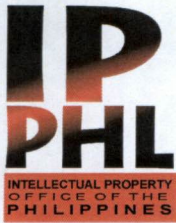


ORDER
