ORDER

ZOETIS SERVICES, LLC ("Opposer") filed on 16 October 2015 an opposition to Trademark Application Serial No. 4-2014-00014262. The application filed by **ALPHA-PHARMA**

HEALTHCARE (PH) INC. ("Respondent-Applicant") covers the mark on goods under Class 05.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to Respondent-Applicant on 11 November 2015. The Respondent-Applicant filed its Answer on 9 February 2016.

In compliance to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation Settlement Period"), this Bureau issued on 15 March 2016 Order No. 2016-037 referring the case to mediation.

On 23 June 2016, the ADR Services of this Bureau submitted a Mediation Report indicating an unsuccessful mediation of the instant case.

However, on 12 December 2016, the Opposer filed a Manifestation confirming its voluntary withdrawal of the Opposition, as manifested by counsel during the preliminary conference held on 28 November 2016.

Accordingly, with the withdrawal by the Opposer of its Opposition, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Application Serial No. 4-2014-00014262 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
