DECISION

SHELL BRANDS INTERNATIONAL AG ("Opposer")¹, filed a Verified Opposition to Trademark Application Serial No. 4-2011-009655. The application, filed by SHELLHOME CHEMICALS INC. ("Respondent-Applicant")², covers the mark "EON, ORIGINAL SHELL RECIPE 2, 4-D" for use on the following: "fertilizers" under class 1; and, "herbicide: preemergent herbice for excellent control of commonly occurring broadleaf weeds, grasses and sedges in transplanted and direct seeded rice; insecticides, fungicides, mollusicides" under class 05 of the International Classification of Goods and Services.³

The Opposer alleges that it is a subsidiary of Royal Dutch Shell pic and together with other Shell subsidiaries, form the Shell Group of Companies. With over 150 years, the Shell Group's business is so diverse that it is organized into Upstream, Downstream and Projects & Technology categories. In the Philippines, the Shell Group established its corporate presence in 1914 in Pilipinas Shell Petroleum Corporation which serves in almost every field of transport, commerce and industry with a wide range of quality fuels, lubricants, liquefied petroleum gas, aviation fuel, bitumen and other specialty products. There are about 1000 SHELL retail service stations selling SHELL products, 24 hours SHELL SELECT convenience stores and selling full range of SHELL world-class lubricants, and the Shell Pilipinas Exploration B.V., a subsidiary company which is the operator of a joint-venture which developed the Malampaya Deepwater Gas-to-Power Project.

The Nice Classification is a classification of goods and services for the purpose of registering trademark and service marks, based on the Nice Agreement Concerning the International Classification of Goods and Services for the Purpose of the Registration of Marks, which was concluded in 1957 and administered by the World Intellectual Property Organization.

According to the Opposer, its trademark SHELL and the PECTEN DEVICE have identified the Shell Group's brand for more than 150 years. SHELL products are advertised and used worldwide. It maintains a global website and country-specific websites for various countries, including the Philippines. The Shell Group holds about 8,000 registrations and applications for its SHELL mark worldwide. The Opposer avers the following grounds for this instant case: (1) The dominant element of the Respondent's mark is SHELL which is identical with Opposer' registered SHELL marks and therefore should be rejected; (2) The SHELL marks are well-known marks; (3) SHELL is Opposer's trade name which has been used for over 150 years and should be protected against Respondent-Applicant's unlawful use; and, (4) Respondent-Applicant has filed the mark SHELLHOME & DEVICE for goods in classes 1 and 5 in bad faith.
