

Please be informed that Order No. 2017 - 57 (D) dated March 02, 2017 (copy enclosed) was promulgated in the above entitled case.

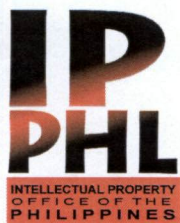
