

## ORDER

ALFA WASSERMANN S.P.A. ("Opposer"), filed on 01 August 2016 an opposition to Trademark Application Serial No. 4-2015-012356. The application filed by EADRIEX PHARMACEUTICALS PHILS., INC. ("Respondent-Applicant"), covers the mark "NORXIME" for use on goods under Class 05. The opposition is anchored on Section 123.1 paragraph (e) of R.A. No. 8293, also known as the Intellectual Property Code of the Philippines ("IP Code").

This Bureau issued a Notice to Answer and served a copy thereof to the Respondent-Applicant on 12 August 2016. The Respondent-Applicant did not file an Answer. On 05 April 2017, this Bureau issued an order declaring the Respondent-Applicant in default. However on 06 June 2017, Respondent-Applicant submitted a Notice of Abandonment stating that it has decided to abandon its application for the trademark NORXIME.

Accordingly, in view of the abandonment by the Respondent-Applicant of the subject trademark application, there is no more reason or basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED. Let the filewrapper of Trademark Application Serial No. 4-2015-012356 be returned, together with a copy of this Order to the Bureau of Trademark (BOT) for information and appropriate action.
