ORDER

CHANEL SARL ("Opposer") filed on 12 October 2015 an opposition to Trademark Application Serial 4-2015-500017. The application filed by MAY JANE S. LACAP ("Respondent-Applicant") covers the mark **NEUTRA ORGANICS MIRACLE NO. 5** for use on goods under Class 3.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to Respondent-Applicant on 11 November 2015. The Respondent-Applicant did not file an Answer.

On 14 July 2017, Respondent-Applicant filed an Express Abandonment of Application with the Bureau of Trademarks stating that she has decided not to pursue the subject application for registration for the mark **NEUTRA ORGANICS MIRACLE NO. 5**.

Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**.
