ORDER

KRISALINO SANCHEZ ("Opposer") filed on 19 October 2017 a Manifestation that:

"1. On January 24, 2017, Oppositor filed two Verified Notices of Opposition to Lifetime's App. Nos. 4-2016-504383 and 4-2016-504255, docketed as Inter Partes Case Nos. 14-2016-00604 and 14-2016-00605 respectively, and which are currently pending with the Bureau of Legal Affairs of the IPOPHL;

2. Oppositor and Respondent-Applicant have agreed to put an end to the pending litigations and avoid future litigations by entering into a Compromise Agreement involving the subject applications, among others.

3. Given the foregoing, Oppositor respectfully manifests that he is no longer interested in opposing the subject applications. Hence, Oppositor respectfully asks the Honorable Office to allow the withdrawal of the Notices of Opposition docketed as follows: Opposition to Trademark App. Nos. 4-2016-504383 and 4-2016-504255, docketed as Inter Partes Case Nos. 14-2016-00604 and 14-2016-00605."

This Bureau treats the Opposer's manifestation as a voluntary withdrawal of its opposition. With the voluntary withdrawal by the Opposer of its opposition, there is no more factual or legal basis to proceed with this case.
