## ORDER

ECHOBROW PTY LTD. ("Opposer"), filed on 19 December 2011 an Opposition to Trademark Application Serial No. 4-2010-007862. This Bureau issued a Notice to Answer and served upon a copy thereof to VIVA ENTERTAINMENT, INC. ("Respondent-Applicant"), on 12 January 2012. The Respondent-Applicant filed its Answer on 13 February 2012.

In compliance to Office Order No. 154, s. 2010 (*'Rules of Procedure for IPO Mediation Proceedings'*) and Office Order No. 197, s. 2010 (*'Mechanics for IPO Mediation Settlement Period'*), this Bureau issued on 05 March 2012 Order No. 2012-60 referring the case to mediation.
