## ORDER

ESPRIT INTERNATIONAL ("Opposer"), filed on 08 August 2012 an opposition to Trademark Application Serial No. 4-2012-002509. The application, filed by HOK DIENG ENTERPRISE INC. ("Respondent-Applicant"), covers the mark "ESPALMA" for use on goods under International Class 24.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to HOK DIENG ENTERPRISE INC. ("Respondent-Applicant") on 13 September 2012. The Respondent-Applicant filed its Answer on 07 November 2012.

In compliance to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation Settlement Period"), this Bureau issued on 04 December 2012 Order No. 2012-222 referring the case to mediation. On 03 January 2013, the ADR Services of this Bureau submitted a Mediation Report indicating the unsuccessful mediation of the instant case.

On 29 April 2013, the Opposer filed a Manifestation and Motion stating that in a letter dated 08 April 203, the Respondent-Applicant confirmed that it was no longer interested in registering the ESPALMA trademark. Attached to the Opposer's Manifestation and Motion is the Respondent-Applicant's letter dated 08 April 2013 addressed to the Director of the Bureau of Trademarks.

Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Application Serial No. 4-2012-002509 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
