ORDER

GINEBRA SAN MIGUEL INC. ("Opposer"), filed on 06 June 2011 an opposition to Trademark Application Serial No. 4-2010-011069 on the ground that the dominant feature "GINEBRA" of the subject mark "GINEBRA GUAVA & DEVICE" is identical to the dominant feature of Opposer's trade name, "GINEBRA SAN MIGUEL, INC.,".

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to TANDUAY DISTILLERS, INC., ("Respondent-Applicant") on 11 July 2011. The Respondent-Applicant filed its Answer on 10 August 2011.

In compliance to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation Settlement Period"), this Bureau issued on 15 August 2011 Order No. 2011-255 referring the case to mediation. On 10 October 2011, the ADR Services of this Bureau submitted a Mediation Report indicating the unsuccessful mediation of the instant case.

On 22 January 2014, the Respondent-Applicant filed a Motion to Withdraw Application stating that it is withdrawing its application for the mark GINEBRA GUAVA & DEVICE.

Accordingly, with the withdrawal by the Respondent-Applicant of its trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Application Serial No. 4-2010-011069 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
