

ORDER

SUYEN CORPORATION ("Opposer"), filed on 23 February 2011 an opposition to Trademark Application Serial No. 4-2010-006277 on the ground of confusing similarity.

Prior to the Bureau's issuance of a Notice to Answer on 10 June 2011, KAO KABUSHIKI KAISHA (also trading as Kao Corporation) ("Respondent-Applicant") filed on 26 May 2011 a Manifestation stating that it has withdrawn its application for registration of the trademark ESSENCE FIX.
