ORDER

THE PRUDENTIAL INSURANCE COMPANY OF AMERICA ("Opposer"), filed on 12 January 2009 an opposition to Trademark Application Serial No. 4-2008-006628 on the ground that the registration of the mark "MOUNTAIN DESIGN" is favor of Respondent-Applicant would be violative of Section 123.1 (d) & (e) of Republic Act No. 8293, otherwise known as the Intellectual Property Code of the Philippines.

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to INVESCO HOLDING COMPANY LIMITED ("Respondent-Applicant") on 17 February 2009. The Respondent-Applicant however did not file an Answer.

On 03 January 2014, the Opposer filed a Motion to Withdraw Opposition in consideration of the worldwide settlement agreement of the parties.

Accordingly, with the withdrawal by the Opposer of its opposition, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**.
