ORDER

TRIANON INTERNATIONAL, INC., ("Petitioner"), filed on 23 May 2013 a petition for cancellation of Trademark Registration No. 4-2011-012124. The petition is anchored on Section 123.1 (g) of Rep. Act No. 8293, also known as the Intellectual Property Code of the Philippines.

On 12 September 2013, PT DEXA MEDICA ("Respondent-Registrant"), filed its Answer to the petition refuting the Petitioner's allegations.

In compliance to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation and Settlement Period"), this Bureau issued on 04 October 2013 Order No. 2013-227 referring the case to mediation.

On 13 October 2014, the parties filed a Joint Manifestation with Motion to Dismiss praying that this Honorable Office order the immediate dismissal of this case, with prejudice, on account of the mutual agreement of the parties.

Accordingly, with the parties' Joint Manifestation with Motion to Dismiss, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant petition case is hereby DISMISSED.

Let the filewrapper of Trademark Registration No. 4-2011-012124, together with a copy of this Order, be returned to the Bureau of Trademarks (BOT) for appropriate action.
