ORDER

YADU 621("Opposer"), filed an opposition to Trademark Application Serial No. 4-2012-503317 on the ground that the registration of the mark "YADU 621" will violate Section 123.1 (d) of R.A. 8293 also known as the Intellectual Property Code of the Philippines ("IP Code").

Pursuant to the Regulations on Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to EDWIN L. SAULO (Respondent-Applicant) on 27 September 2013. The Respondent-Applicant filed his Answer on 26 November 2013. However, the Answer was filed out of time.

On 27 February 2014, this Bureau issued Order No. 2014-41 referring the case to mediation. On 21 April 2014, the ADR Services of this Bureau submitted a Mediation Report indicating a settlement by the parties. On 06 June 2014, the Opposer filed a Motion to Withdraw Opposition stating that it is withdrawing the instant opposition.

Accordingly, in view of the withdrawal by the Opposer of its opposition to the subject trademark application, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby DISMISSED.

Let the filewrapper of Trademark Application Serial No. 4-2012-503317 be returned, together with a copy of this Order to the Bureau of Trademark (BOT) for information and appropriate action.
