ORDER

APPLE INC., ("Opposer"), filed an opposition to Trademark Application Serial No. 4-2012-502354. The application filed by FAUSTINO L. CO SHU KIAM ("Respondent-Applicant") covers the mark WIPOD AND DEVICE for use on goods under Class 07. The opposition is anchored on Section 123.1 paragraphs (d), (e), (f) and (g) of R.A No. 8293, also known as the Intellectual Property Code of the Philippines ("IP Code").

Pursuant to the Regulations on the Inter Partes Proceedings, this Bureau issued a Notice to Answer and served a copy thereof to Respondent-Applicant on 23 July 2013. the Respondent-Applicant however, did not file its Verified Answer. On 18 December 2013, this Bureau issued Order No. 2013-1683 declaring Respondent-Applicant in default for failure to file an answer.

On 27 October 2014, however, the Opposer filed a Manifestation stating that the instant opposition case should already be dismissed. Attached to the Manifestation is the photocopy of the letter as filed with the Bureau of Trademarks (BOT) dated 23 August 2013, to wit:

"I hereby respectfully manifest that I am no longer interested in registering the 'WIPOD AND DEVICE' trademark, covered by the above mentioned trademark application, or from otherwise pursuing my trademark application therefor.

Accordingly, I hereby respectfully request that this letter be included in the filewrapper of Trademark Application Serial No. 4-2012-502354 for 'WIPOD AND DEVICE', and that said application be deemed by the Bureau of Trademarks as abandoned."

With the express withdrawal or abandonment by the Respondent-Applicant of Trademark Application Serial No. 4-2012-502354, there is no more reason nor basis to proceed with this case.
