ORDER

DAIMLER AG ("Opposer") filed on 16 December 2014 a Manifestation and Motion to Dismiss. The Manifestation and Motion states that:

"1. In connection with the subject matter of this case, Respondent-Applicant UNITED ASIA AUTOMOTIVE GROUP, INC. has filed before the Intellectual Property Office of the Philippines Bureau of Trademarks Request for Voluntary Withdrawal of Application No. 4-2014-001990 for the mark "SMART SOLUTIONS" on 11 November 2014 through its authorized Representative Ms. Ruby Grace Dimaano. A copy of the said request together with the corresponding proof of payment thereof is attached herewith and marked as Annex A.
