ORDER

INCIPIO TECHNOLOGIES, INC. ("Opposer"), filed on 08 September 2014 a Manifestation stating among other things:

- 1. On September 3, 2014, Opposer and Respondent came to an agreement to amicably settle the present case after Respondent acknowledged and recognized Opposer as the true and lawful creator and owner of the world-renown subject mark as well as the other INCIPIO marks and/or logos.
- 2. Respondent also agreed to refrain from filing or otherwise seeking or pursuing registrations, domain names and/or intellectual property interests that incorporate or otherwise use any of the Incipio marks and/or logos, (including those reproduced above) or derivatives or colorable imitations thereof.
- 3. Enclosed for this Honorable Office's reference is a copy of the notarized COMPROMISE AGREEMENT WITH ASSIGNMENT OF PENDING TRADEMARK APPLICATION dated September 3, 2014.
- 4. In view of the foregoing and to avoid any further delay, the above-captioned opposition case may now be terminated as the dispute in issue is moot.

Accordingly, with the Manifestation filed by the Opposer, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**. Let the filewrapper of Trademark Application Serial No. 4-2013-006388 be returned, together with a copy of this Decision, to the Bureau of Trademarks for information and appropriate action.
