Please be informed that Order No. 2017 – 51 (D) dated March 01, 2017 (copy enclosed) was promulgated in the above entitled case.

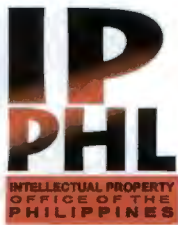
