
Please be informed that Order No. 2017 - <u>IID</u> (D) dated May 22, 2017 (copy enclosed) was promulgated in the above entitled case.

EDUARDO G. PASTOREL AND ALLIED MACHINERY PRODUCTS INC., ("Opposers") filed an opposition to Trademark Application Serial No. 4-2011-500319. The application filed by BRIGGS AND STRATTON CORPORATION ("Respondent-Applicant") covers the mark "VANGUARD BRIGGS AND STRATTON LOGO" for use on goods under Class 07. The opposition is anchored on Section 123.1 (d) (e) (f) and (g) of R.A. 8293 also known as the Intellectual Property Code of the Philippines ("IP Code").

This Bureau issued a Notice to Answer and served a copy thereof to the Respondent-Applicant on 27 April 2012. The Respondent-Applicant filed its Answer on 26 July 2012.

Pursuant to Office Order No. 154, s. 2010 ("Rules of Procedure for IPO Mediation Proceedings") and Office Order No. 197, s. 2010 ("Mechanics for IPO Mediation and Settlement Period"), this Bureau issued on 03 August 2012 Order No. 2012-164 referring the case to mediation. The mediation, however, was terminated and the preliminary conference was conducted.

In compliance with Order No. 2016-1619 and the order given in open court during the hearing held on 22 March 2017, the Respondent-Applicant filed on 27 March 2017 a Compliance submitting the parties' Settlement Agreement signed by Eduardo G. Pastorel and Briggs & Stratton Corporation dated 17 February 2015 and 25 March 2015 respectively.

Accordingly, with the Compliance filed by the Respondent-Applicant, there is no more reason nor basis to proceed with this case.

WHEREFORE, premises considered, the instant opposition case is hereby **DISMISSED**. Let the filewrapper of Trademark Application Serial No. 4-2011-500319 be returned, together with a copy of this Order to the Bureau of Trademarks (BOT) for information and appropriate action.
