Please be informed that Order No. 2017 - 83 (D) dated April 19, 2017 (copy enclosed) was promulgated in the above entitled case.

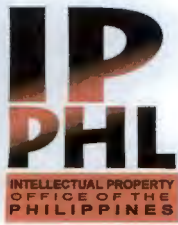
