
Please be informed that Order No. 2017 - 134 (D) dated June 09, 2017 (copy enclosed) was promulgated in the above entitled case.

# ORDER

AQTIS I.P. BV and SINCLAIR PHARMACEUTICALS LTD. ("Opposers") filed on 16 May 2017 a Manifestation stating, among other things, that:
